Guidelines for Fund B for Service to Others Trinity United Methodist Church Evansville, Indiana 2023

Trinity United Methodist Church announces its 2023 Fund for Service to Others (Fund B) grant program.

Our goal is to encourage grant applicants to request monies sufficient to successfully complete a project by providing the committee relevant and persuasive information for review.

Historically, Fund B grants have ranged from a low of \$500 to a high of \$10,000. We invite applicants to determine an appropriate amount for the project and make that request.

Trinity United Methodist Church's congregation rejoices in assisting the community through the Fund for Service to Others. Applications are evaluated based on the following general criteria:

- Project fits and supports Trinity's mission: growing passionate disciples of Jesus Christ for the transformation of the world.
- Funds serve others in our community— within Vanderburgh and contiguous counties.
- Grants are awarded to help the needy.
- Projects addressing spiritual as well as physical needs receive priority.
- Funds do not directly benefit Trinity members.
- Recipients will engage Trinity members as volunteers if possible.

However, we do not grant requests for:

- medical expenses;
- endowments;
- capital building costs;
- lobbying;
- fundraising events;
- individuals; and
- non-tax-exempt organizations.
