Trinity United Methodist Church announces revisions to its Fund for Service to Others (Fund B) grant program.

Modifications to the program are necessitated by a number of internal factors. Our goal is to encourage grant applicants to request monies sufficient to successfully complete a project by providing the committee relevant and persuasive information for review.

Historically, one-year grants have ranged from a low of \$500 to a high of \$10,000. We invite applicants to determine an appropriate amount for the project and make that request.

Trinity United Methodist Church's congregation rejoices in assisting the community through the Fund for Service to Others. Applications are evaluated based on the following general criteria:

- Project fits and supports Trinity's mission: growing passionate disciples of Jesus Christ for the transformation of the world.
- Funds serve others in our community— within Vanderburgh and contiguous counties.
- Grants to help the needy.
- Projects addressing spiritual as well as physical needs receive priority.
- Funds do not directly benefit Trinity members.
- Recipients will engage Trinity members as volunteers if possible.

We remind you, however, that we do not grant requests for:

- medical expenses;
- endowments;
- capital building costs;
- lobbying;
- fundraising events;
- individuals; and
- non-tax-exempt organizations

We invite you to apply for a Fund B grant with this admonition “Dream the unthinkable, attempt the impossible. Be audacious. It is the magic of the idea that will lead your organization to victory.”
